



## Terms & Conditions

VODAFONE INDIA LIMITED, VODAFONE MOBILE SERVICES LIMITED, VODAFONE WEST LIMITED, VODAFONE EAST LIMITED, VODAFONE SOUTH LIMITED, VODAFONE DIGILINK LIMITED, VODAFONE CELLULAR LIMITED & VODAFONE SPACETEL LIMITED (hereinafter each referred to as “**VODAFONE INDIA**”) brings the **Double Validity Offer** (hereinafter referred to as “**Offer**”) for its valid<sup>1</sup> Prepaid Cellular Mobile Subscribers (“**Subscriber**”) subject to the following Terms and Conditions mentioned below (hereinafter “**Terms**”).

Double Validity Offer is a limited period Offer available for Subscribers of Vodafone India across all the circles (who have spent a minimum of 30days on the network) that recharge for specific Voice Rate Cutter/Bonus Card during the Offer Period purchased from the Vodafone online portal ([www.vodafone.in](http://www.vodafone.in)) and/or through \_\_\_\_\_. This Offer is available only for products featuring on the customized 121 Made for You platform.(hereinafter “121 platform”, marked with a ‘DOUBLEVALIDITY’ prefix
2. The Offer is open from 00:00 hrs of 24/07/2015 to 23:59 hrs of 30/09/2015(“**Offer Period**”). Vodafone India may extend or shorten the Offer Period as they may deem fit and proper.
3. Under this Offer, the Subscriber shall be eligible for doubling the validity of original Voice Rate Cutter/Bonus Card availed from 121 Made for You customized platform by an equivalent number of days subject to recharge of an additional Bonus Card of Rs. 7 in the ‘**Valid Period**’.
